GENERAL INFORMATION

Slido: Some of the plenaries will be using the Slido App for voting. Registrants will be provided a participant code prior to the event and encouraged to download the application onto their device for use during the plenary sessions. For more on Slido, visit https://www.slido.com/.

Hotel: For the convenience of conference registrants, a block of rooms has been reserved at the Silverado Resort & Spa, 1600 Atlas Peak Road, Napa, CA 94558. Please reserve your room by calling +1 (800) 532-0500 and asking for the College of Commercial Arbitrators group rate or visit https://tinyurl.com/CCA25Hotel to book your reservation online. To ensure availability please make your reservation as soon as possible. The reservation deadline is September 19, 2025. After that date, or when the room block is exhausted, the hotel will assign rooms on a space and rate available basis only. The conference rates range from \$429 plus tax (standard Mansion or Cottage room) up to \$509 plus tax (1-bedroom suite.) A \$35+tax/night resort fee covers self-parking, wi-fi internet access in meeting and guest rooms throughout the property, unlimited local/toll-free calls from your room, inroom coffee/tea, tennis courts, access to the fitness facility and fitness classes, golf bag storage and property-wide transportation. A one-night deposit is required at the time of reservation. Please note in the event of room cancellation, the deposit is refundable if notice is received by the hotel at least 7 days prior to arrival. Cancellations within 7 days of arrival will incur a cancellation fee equal to the full length of stay.

Airport & Transportation: The closest regional airport is the Sonoma County Airport in Santa Rosa (STS) ~45 miles (60-minute drive) from the Silverado Resort. The closest major airports are the Oakland International Airport (OAK) ~55 miles (80-minute drive), San Francisco International Airport (SFO) ~63 miles (100-minute drive) or the Sacramento International Airport (SMF) ~67 miles (80-minute drive). Rideshares from the major airports are estimated at \$100-130 each way and taxi fare at ~\$180+ each way. Private shuttle service and rental car services are also available at the major airports.

Parking: Self-parking is complimentary for resort guests and included in the daily resort fee.
